PREPARATION OF THIS ACCESSIBILITY STATEMENT

This statement was prepared on 09.01.2023 and last reviewed on 02.02.2023. The basis for issuing this accessibility statement is an assessment carried out by the TU Dresden on 06.12.2022.

COMPLIANCE STATUS

Due to the following non-compliances and/or exemptions, this website is partially compliant with the requirements of the BfWebG in conjunction with BITV 2.0.

NON-ACCESSIBLE CONTENT

- Contrasts
 - > Due to an internal design guideline the contrasts are currently not adjustable
 - > Adjustment is planned
- Headings or the heading hierarchy are not implemented correctly in every case
 - > Adjustment of headings will be done in the long term. Currently this is not feasible due to resource constraints.
- Image descriptions
 - > In the internal area of our website not all images (especially photos) are provided with image descriptions. Since there are a lot of photos, it is currently impossible for us to add the descriptions (due to resource constraints). In addition, the user group for the internal area is very limited. Here, only project leaders and staff have access after their membership has been checked by the admin. It is a small circle of members who are in close contact with us.
